

Application



- Official high school transcripts or high school equivalency (GED) must be submitted to the office of Admissions and Records in the One Stop Center
 - Transcripts must be official
 - They can be sent directly to Morton College from your previous institution
 - Or you can bring a sealed copy (do not open the envelope or ٠ they cannot be accepted) to the Admissions Office
 - Please notify the health recruiter once you have submitted your transcripts so your file can be properly updated
 - Deadline is May 22, 2025 at 4:30pm

Application



- Foreign transcripts must be evaluated by a foreign credential agency accredited by the National Association of Credential Evaluation Services (NACES) (must state "has the equivalency of a U.S. High School diploma)
 - Deadline is May 22, 2025 at 4:30pm lacksquare
- **Proof of Residency status** applicants wanting in district consideration (whether living in -district or May 22, working in -district) must submit proof by 2025

Joint Agreement

If you live out -of-district you can acquire a joint agreement at your corresponding community college to be considered in -district at Morton College. Please note, this only applies to you if your corresponding community college a Physical Therapist Assistant Program.

Joint Agreement

• You must submit the joint agreement request to your corresponding community college at least 30 days prior to the semester starting. your corresponding community college in case, they require additional time beyond the 30 days

• Please note : all community colleges have different policies regarding their joint agreement. Please inquire early on regarding the joint agreement guidelines at your corresponding community college to assure you have the joint agreement submitted on time at Morton College.

Admission Requirements

- Mandatory attendance at a PTA Information Session.
- Successful completion of MAT 093 or higher, or placement into MAT 097 or higher on the Morton College math placement exam (two attempts are allowed) or equivalent.
- Participation in an interview for inclusion and exclusion purposes with the PTA Program Admissions Committee (interview letters will be emailed to eligible applicants after January 14, 2025)
- Minimum cumulative GPA of 2.0.



Prerequisite Coursework

Successful completion of the following college courses, by the end of the Spring 2025 semester, with a minimum grade of "C" in each and completed within 5 years of beginning the program:

- ENG 101 Rhetoric I (Fall 2020 or after) or placement into ENG 101 on Accuplacer placement test •
- PHT 101 Medical Terminology (Fall 2020 or after)
- BIO 152 Anatomy and Physiology (Fall 2020 or after) •
- PHY 100 OR equivalent Fundamentals of Physics (Fall 2020 or after). •
- Note: Proof of minimum course completion or in-progress status for program pre-requisites must be submitted no later than ٠ February 14th, 2025 to be considered for an interview for the PTA program.



Prerequisite Coursework

Please note:

- All prerequisite work MUST be completed
- NO LATER THAN SPRING
 2025



General Education Coursework

The following courses may be completed prior to admission, or during the PTA program. However, it is highly recommended that they be completed prior to admission.

- ENG 102 Rhetoric II/SPE 101 or equivalent
- **PSY101** Introduction to Psychology
- PSY210 or 215 Child Growth and Development or Life Span: Survey of Human Development
- Humanities no admissions points granted for humanities courses

Note: Admission points will be granted for the courses above that are taken up until the end of Spring 2025 with the exception of the humanities courses.

Note: PSY101 is a pre-requisite of PSY210 and 215 and cannot be taken concurrently.

General Education Coursework

Please note: You do not have to complete all your general education coursework before applying to the program. However, it would improve your score and make you a stronger candidate as an applicant.



Curriculum

• Degree Earned:

Associate's in Applied Science



- Length of the Program:
 - 2 years, Fall/Spring Semesters (17 weeks), no summer courses
- Instructional Methods:

Lecture, Lab, Hybrid Online, and Clinical Internship

- 3 Required Clinical Affiliations: (4 weeks, 6 weeks, and 7 weeks)
- A criminal background check and physical examination/drug screen are required
- Students are required to have their own transportation
- Must pass each clinical affiliation in order to graduate from the program



Student Responsibilities for Clinical Affiliations

All students are responsible for the following:

- Being registered with tuition and fees paid for each Clinical Affiliation prior to its starting date.
- Completing required clinical health requirements, which include but is not limited to; criminal background check, 10 -panel drug screen, and have health insurance. More information once admitted into the PTA program.
- Students are responsible for all costs associated with each clinical affiliation.



Clinical Site Assignments

- Clinical sites are currently located throughout the greater Chicago area, in several counties surrounding metropolitan Chicago, and in northwestern Indiana.
- No guarantees will be made regarding the distance that students must travel to and from the clinical sites. Clinical assignments may involve out -of-town travel/accommodations.
- The Academic Coordinator of Clinical Education (ACCE) schedules and assigns students to clinical experiences. Students are given opportunities to share information with the ACCE regarding their interests and preferences for locations and types of facilities for each level of clinical education.
- The final decision for the clinical assignment is made by the ACCE.

Please note: There are vaccination requirements.




